Arrive Alive - Distracted Driving Update

Child Passenger Safety Technician Course - Missoula

It was discussed that many members of BUMT also attend the Safe Kids meeting with an hour between the two meetings. It was discussed how combining the BUMT meeting with the DUI Task Force would save those particular members several hours during the day we hold the BUMT meetings.
