House Bill 109 - Primary Seat Belt Law

House Bill 256 – Rewording of CPS Language

- 3<sup>rd</sup> Reading has passed the house and it's been refered the Highway Transportation Committee

- Changes the height, age, and weight requirements for children
- Hearing scheduled for Feb 2<sup>nd</sup>.
